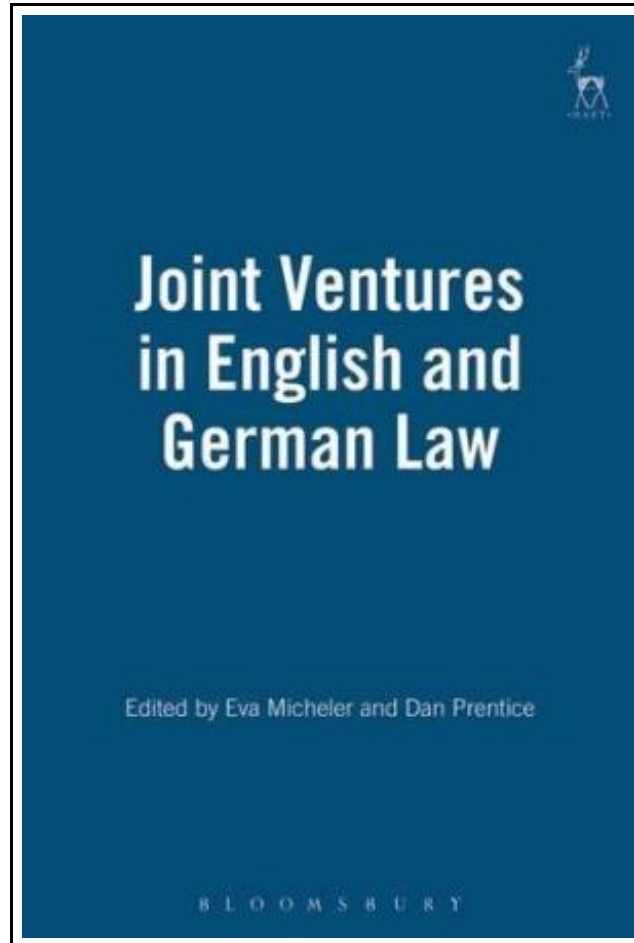

This part also describes the relevant laws protecting employees. The third part addresses European Union as well as English and German competition law.
